1 INTRODUCTION

This document provides principles for calculating fees for accreditation services and GLP as well as the method of payment for services provided by the Slovak National Accreditation System (hereinafter only the "SNAS").

2 RELATED DOCUMENTS

ISO/IEC 17011:2017 Conformity assessment - General requirements for accreditation bodies accrediting conformity assessment bodies

European Parliament and Council Directive (EC) no. 765/2008 laying down requirements for accreditation and market surveillance concerning placing products on the market and repealing the Directive (EEC) no. 339/93 (Text with EEA relevance)

The Act no. 67/2010 Coll. on conditions of placing chemical substances and chemical mixtures on the market and on the amendment and supplementation of certain acts (Chemical Act) as amended

The Act no. 222/2004 Coll. on value added tax as amended

The Act no. 53/2023 Coll. on the accreditation of the conformity assessment bodies

The Act no. 146/2023 Coll. on air protection and on the amendment and supplementation of certain laws

3 PAYMENT FOR SNAS SERVICES

Price list for SNAS services includes rates and conditions of their application pursuant to the Act no. 53/2023 Coll. on the accreditation of the conformity assessment bodies and pursuant to the European Parliament and Council Directive (EC) no. 765/2008. The non-profit and transparency principle is applied in accordance with the principles of ILAC, IAF and EA as well as with the principle of equal treatment with all accreditation applicants and accredited bodies.

All rates included in the Price list of services are stated excluding the value added tax (VAT). VAT shall be added to the rates included in the Price list of services in the amount as set forth by the law.

SNAS shall provide information and data on calculation of fees for a specific service free of charge.

Invoices for provided accreditation, reaccreditation and extended accreditation - shall be issued after the day on which decision on granting accreditation / certificate was issued.

Invoice for surveillance shall be issued after the day of decision of:

1. competent managing department (if result of surveillance isn't a change),

2. director (if result of surveillance is a change),
3. director (for every GLP surveillances).

Invoice for preliminary assessment shall be issued after the assessment.

Invoice for annual fee for maintaining accreditation shall be issued until the end of January of the respective year.

Each invoice shall be due within 30 days after issuance. Based on a request of the applicant / accredited body / certificate holder, for whom a SNAS service is provided, extended maturity may be agreed; however, it shall not exceed 60 days after the date of issue.

For applicant / accredited body / certificate holder established outside of the Slovak Republic, maturity period can be agreed otherwise as mentioned above, however, it shall not exceed 60 days after the date of issue. An advance payment prior to the performance of assessment on site may be required under the contract.

Payments for provided services shall be made based on issued invoices via wire transfer to the SNAS's bank account held with the Statna pokladnica, Radlinskeho 32, 810 05 Bratislava, Slovakia, IBAN: SK02 8180 0000 0070 0036 9571.

4 TYPES OF FEES

The Price list contains detail rules on calculating the following fees:

- Application fee;
- Fees for actions in the provision of the accreditation services (accreditation, reaccreditation, surveillance...);
- Annual fee for maintaining accreditation;
- Other fees.

5 APPLICATION FEE

Fee related to submission, registration and assessment of application is EUR 600 for each field of accreditation. The fee is due only with the first application for accreditation, when applying for an extension of another management system, a sector-specific scheme for certification bodies, and a request for the granted of a GLP compliance certificate. The applicant's identification number (IČO) is indicated as a variable symbol. The invoice (tax document) will be issued upon receipt of payment.

The fee shall be paid in advance when submitting the application and it is non-refundable.

6 FEES FOR ACTIONS IN THE PROVISION OF ACCREDITATION SERVICES AND GLP

Overview of rates is divided according to individual fields of accreditation and individual tables contain basic rates for accreditation, reaccreditation, surveillance and annual fee for maintaining accreditation. Basic rates (in EUR) are divided into categories depending on the number of determining data from the scope of accreditation included in the following table.

Calculation of basic fees depends on the average time needed for complex assessment of meeting all accreditation requirements. The calculation includes all costs related to administrative works associated with provided accreditation service, study and assessment of the subject's documentation, costs for on-site assessment as well as costs for assessment completion.

Amount of the fee shall be notified to the applicant / accredited body / certificate holder together with a Proposal of the composition of the Assessment Group through the Accreditation Information System.

The basic rates are further regulated depending on time necessary for complex assessment of meeting all accreditation requirements, particularly:

- Assessment of more workplaces or workplaces situated in several locations;
- Assessment of flexible scope in case of laboratories;
- Assessment of employees expressing opinions and interpretations;
- Supplementary assessment of requirements according to a different standard;
- Assessment of integrated management systems;
- Witness assessment (of certification bodies and verifiers).

In case of applicant / accredited body / certificate holder with several workplaces or several places of business, the fee shall be further adjusted. For every additional workplace / place of business, (unless explicitly stated otherwise below) the fee shall be increased by 25 per cent of the fee of respective category according to the number of determining data from the scope of accreditation in the given workplace/place of business. (Note: for purpose of the fee calculation: first workplace / place of business is one that has the highest number of determining data).

Particularities in individual fields of accreditation shall be taken into consideration through additional financial units specified below individual tables.

In other cases (e.g. extraordinary assessment, preliminary assessment, transfer of accreditation, supplementary assessment of requirements according to a different standard, evaluation of conformity with a new or updated regulation etc.) the hourly rate is used to calculate. The time capacity will be determined based on the actual time required for the assessment, including the preparation and completion of the assessment.

The rate for extension shall be calculated by multiplying the number of hours required for extension of accreditation (time required for taking into account necessary of assessment including the preparation of the assessment, on-site assessment and completion of the assessment) and hourly rate.

6.18 EXTRAORDINARY ASSESSMENT

Fee for extraordinary assessment shall be calculated by multiplying the number of hours required for extraordinary assessment (time required for taking into account necessary of assessment including the preparation of the assessment, on-site assessment and completion of the assessment) and hourly rate.

Payment for extraordinary assessment on the basis of a complaint or other submission to an accredited body, which arise to SNAS during the review of a complaint or other submission to an accredited body, will be invoiced to the person who submitted the complaint or other submission to the accredited body, if it is proven that the complaint or other submission to accredited body was unjustified.

6.19 WITNESS ASSESSMENT

The prescribed number of witness assessment in case of certifying bodies and verifiers is stated in applicable methodological accreditation guidelines (MSA-CO/03, MSA-CP/03, MSA-CS/15, MSA-E/05, MSA-V/03).

6.20 PRELIMINARY ASSESSMENT

Fee for preliminary assessment shall be calculated by multiplying the number of hours required for assessment (time required for taking into account necessary of assessment including the preparation of the assessment, on-site assessment and completion of the assessment) and hourly rate.

6.21 SUPPLEMENTARY ASSESSMENT OF REQUIREMENTS ACCORDING TO A DIFFERENT STANDARD

For supplementary assessment of accreditation requirements according to a different standards for other areas of accreditation (e.g. ISO/IEC 17020 + ISO/IEC 17025 or ISO/IEC 17065 + ISO/IEC 17021-1), the basic rate is increased by an amount determined as the product of the number of hours required for the implementation of supplementary assessment of the requirements of another standard (time required for taking into account necessary of assessment including the preparation of the assessment, on-site assessment and completion of the assessment) and hourly rate.

6.22 CROSS-BORDER ACCREDITATION

The basic rate is increased by EUR 976 for administrative tasks associated with cross-border accreditation.

If the accreditation services for SNAS is subcontracted and performed by another foreign accreditation body, SNAS shall add to the price calculated by the foreign accreditation body (excluding travel costs if they are calculated separately) costs related to administrative preparation and completion of the cross-border accreditation service amounting of EUR 976.

If SNAS performs the accreditation service upon request of another foreign accreditation body, it shall be added to the amount of the fee determined as the product of the number of hours required to perform the accreditation service (time taking into account the necessary scope of assessment including the preparation of the assessment, on-site assessment and completion of the assessment) and the hourly rate, costs related to administrative preparation and completion of the cross-border accreditation service amounting of EUR 976.

6.23 TRAVEL, LODGING AND OTHER COSTS RELATED TO ASSESSMENT

Travel expenses and other costs (e.g. lodging) of members of the assessment team are for the performance of services in the territory of the Slovak Republic included in the calculated amount in accordance with the above procedures.

For applicants / accredited bodies / certificate holders based in the Slovak Republic, for whom the assessment is performed by foreign assessors or experts, as well for applicants / accredited bodies / certificate holders based outside the Slovak Republic and for services provided outside the Slovak Republic, the travel expenses expenses (accommodation, transport, visa fees, etc.) and other costs (e.g. interpreting services, processing of services outside of the Slovak Republic, increased time spent by assessment in foreign language , etc.) shall be calculated separately, in "Other necessary costs" for the accreditation service and shall be invoiced in the amount of actual costs.

For the time spent traveling on services outside the Slovak Republic (back and forth), the financial compensation will be applied as follows: if transport takes less than 4 hours, double of the hourly SNAS rate for each assessor; if transport takes more than 4 hours and less than 8 hours, quadruple of the hourly SNAS rate for each member of the assessment

team; for transport lasting more than 8 hours, eight times of the hourly SNAS rate for each member of the assessment team.

6.24 SPECIAL CASES

If the accreditation service may not be completed from reasons on the part of the applicant / accredited body or if SNAS and the applicant / accredited body / certificate holder agree that it is no longer possible to proceed in accordance with the assessment plan, the invoice shall include performed activities (up to 100 per cent).

If SNAS paid non-refundable travel or lodging costs, they shall be invoiced to the applicant / accredited body / certificate holder in the full amount.

If using of the services of a foreign assessor / expert (e.g. because the applicant / accredited body / certificate holder refuses Slovak assessors / experts respectively in the Slovak Republic is not required assessor / expert or abroad it is necessary to use the local assessor / expert) is necessary, all costs incurred in this connection shall be invoiced in the amount of actual costs.

7 ANNUAL FEE FOR MAINTAINING ACCREDITATION

SNAS shall charge the accredited bodies an annual fee for maintaining accreditation to ensure proper functioning of the accreditation system in accordance with requirement of international accreditation organisations, whose membership is essential for SNAS (EA, ILAC, IAF).

Annual fee for maintaining accreditation must be paid on an invoice bases.

If an applicant is granted accreditation during the year, it shall be charged the aliquot part of the annual fee. Suspension of accreditation of an accredited body shall not affect payment of the annual fee. If the accreditation is ceased or repealed during the year, the aliquot part of annual fee is refundable.

The rates of the annual fee for maintaining accreditation are listed above in the individual tables according to the areas of accreditation, depending on the number of determining data from the scope of accreditation.

In the case of certification bodies certifying management systems, the rate is for one accredited system. For each additional management system (integrated management systems), this is increased by EUR 300; whereas the basic management system for calculation purposes is considered to be the management system with the highest degree of complexity.

If one legal person has accredited several laboratories, inspection bodies or certification bodies or their combination, the annual fee for maintaining accreditation shall be calculated as a sum of fees for the individual granted accreditations.
