## **5 STATUTE OF SNAS EVALUATION COMMISSIONS**

### **5.1 MISSION OF THE HK**

5.1.1 SNAS Evaluation Commissions are an advisory body to the Director. They are established by the SNAS Director. They are composed of internal and external SNAS personnel.

5.1.2 The mission of the SNAS Evaluation Commissions is to discuss and assess whether a procedure is adequate and correct for assessment of cases from the scope of accreditation for which it is intended. The commissions, in conducting their activities, apply the independence, impartiality and transparency principles in line with the documents of the relevant international accreditation organizations. The outcome from their assessment is a resolution, recommendation or non-recommendation to grant SNAS accreditation to the concerned entity.

### **5.2 SNAS EVALUATION COMMISSION FOR ACCREDITATION OF LABORATORIES AND INSPECTION BODIES**

SNAS Evaluation Commission for accreditation of laboratories and inspection bodies (HK-LI) is intended for the following areas:

1. Accreditation of:
  - Calibration laboratories,
  - Testing laboratories,
  - Medical laboratories,
  - Proficiency testing organizers,
  - Inspection bodies,
  - For notification of measurement of emissions from stationary sources,
2. Attestation of fulfilment of authorization/notification requirements (for the above areas)

### **5.3 SNAS EVALUATION COMMISSION FOR ACCREDITATION OF CERTIFICATION BODIES AND VERIFIERS**

SNAS Evaluation Commission for accreditation of certification bodies and verifiers (HK-CO) is intended for the following accreditation areas:

- Products certification bodies,
- Management systems certification bodies,
- Persons certification bodies,
- Environmental verifiers,
- For notification/authorization purposes,

- Greenhouse gas emissions verifiers.

#### **5.4 MEMBERS OF SNAS EVALUATION COMMISSIONS**

The members of SNAS Evaluation Commissions are appointed and withdrawn by the Director (TL 602). They include SNAS employees and other impartial officials from interested entities with regard to their specialization and experience in accreditation schemes that are provided by SNAS (qualifications requirements for HK members are in ST-02, Annex 3). HK members who are external personnel sign a “Statement” (TL 02) in which they undertake the commitment to maintain secrecy of matters they will learn in relation to deliberations of the SNAS evaluation commission and are related to protection of copyright and confidential information.

The SNAS Evaluation Commissions are managed by SNAS Evaluation Commission chairs who generally are the heads of the respective SNAS departments.

The lists of SNAS evaluation commissions are in Annexes 2 and 4.

## **6 RULES OF PROCEDURE FOR SNAS EVALUATION COMMISSIONS**

### **6.1 RIGHTS AND RESPONSIBILITIES OF HK MEMBERS**

#### **6.1.1 The HK chair:**

- Sets the date for SNAS HK meetings,
- Manages the course of the SNAS HK deliberations,
- Is responsible for the SNAS HK activities,
- Produces in AIS record in the part “HK meeting” that also includes the resolution,
- Determines relevant corrective actions on the basis of non-conformities and shortcomings identified during the accreditation process,
- In the chair’s absence the deliberations of the SNAS Evaluation Commission are managed by the vice chair or another authorized member.

#### **6.1.2 HK members:**

- Attend deliberations of the respective SNAS Evaluation Commission personally or remotely, through information and communication technologies,
- Give their positions on correctness of the assessment procedure, legitimacy and correct formulation of findings and on pertinence to eliminate non-conformities,
- Formulate proposals of positions and recommendations for the concerned SNAS Evaluation Commission,
- Have the right to demand that the minutes from the SNAS Evaluation Commission include their individual formulated positions to the discussed cases,
- Supervise the objectiveness, consistency and observance of the necessary extent

of the assessment,

- Consistently maintain secrecy of matters they will learn in relation to deliberations of the SNAS Evaluation Commission which are related to protection of copyright and confidential information.

### 6.1.3 The HK SNAS secretary:

- Is not a commission member but carries out the administrative and organizational activities associated with the commission's activities,
- Keeps the agenda of the respective SNAS Evaluation Commission,
- Prepares supporting materials for deliberations of the SNAS Evaluation Commission in line with the instructions from the chair,
- Makes sure the members of the SNAS Evaluation Commission attend the deliberations upon instruction from the chair.

## 6.2 DELIBERATIONS OF A SNAS EVALUATION COMMISSION

- a) Can be held if at least two commission members are present in addition to the person chairing it. Connecting by teleconference, videoconference or written opinion to the agenda is considered to be present at the meeting,
- b) In the event that a member of the SNAS HK was/is an interested party to the assessed case, he or she will **not participate** in the concerned portion of the deliberations,  
(if the chair of the SNAS Evaluation Commission is an interested party to the case, the management of the concerned portion of the deliberations are managed by the vice chair, and if the vice chair is also not impartial in the concerned case, the chair appoints another member of the SNAS Evaluation Commission to manage the deliberations),
- c) If the technical guarantee also assigned a reviewer for the case, the reviewer may be invited to the deliberation of the concerned case without right to vote,
- d) If the head of the HK assigned an external expert, the concerned expert is invited to the deliberation to give his professional opinion but has no voting right,
- e) The outcome of the SNAS HK deliberations through AIS is the HK's position under the bookmark "SNAS HK meeting" and the Director's decision under the bookmark "Finalization" that includes Recommendation for the SNAS Director or Return for completion.
- f) Resolution by SNAS HK is adopted on the basis of consensus agreement of the attending members and if consensus cannot be reached it is adopted through an absolute majority vote of the attendees. A secret ballot can be taken upon request of at least two attending members.
